### SUPERINTENDENT'S REPORT

- 1. 14<sup>th</sup> consecutive highest report card rating. 2nd time to earn the Excellent with Distinction rating.
- Cleveland Museum of Art working with 8 students through 2 teachers as Museum Ambassadors. They have the opportunity to see the museum behind the scenes and work with other University Circle establishments.
- 3. 3 WHS musicians selected for OMEA Regional Orchestra. 145 school districts in our region. Taeho also the top chair for strings in All Ohio Orchestra.
- 4. Lauren Golick is Division I tennis state champion. Lauren an exceptional student as well. Threetime state tournament placer.
- 5. Football team is 8-1, plays on Friday (Senior Night) for a chance to win a conference title and secure a home game.
- 6. Soccer boys and girls won SWC Conference and Districts.
- 7. Parkside Intermediate 5<sup>th</sup> grade teacher, Bridget Royce, chosen to present research at state math conference on strategies for instruction.

# MASTER FACILITIES PHASE I REPORT/DAVE PUFFER

- 1. Will start seeing more inside workers as we finish exteriors and move inside.
- WHS gym brick veneer walls 100% complete. Pre-cast 2<sup>nd</sup> floors 80% complete. Steel columns and bar joists continuing to be installed. Rotunda steel columns and bar joints 85% complete. Fire alarm system installation beginning. Plumbing and electrical lines going up in CMU walls.
- 3. MS Hoping to have building totally dried in by Nov. 1. On Friday, final steel beam placed at far end of academic wing. All middle school students came out to sign the beam. Almost 95% of bearing walls are complete. Roofing, interior walls, door frames going in. Curb preparation of driveway to LBMS almost complete. Final grading on retention basin being completed.
- 4. Ohio EPA changed asbestos abatement. To accommodate that at the middle school, came up with a plan to give contractor early access to parts of the high school. Identified music areas and main gymnasium as a possible way to make up for extra time for asbestos abatement. Two phases. Will vacate around April 15 the music area for asbestos abatement. Then move to main gymnasium with locker rooms. Able to start selected demolition in that area on June 2. Important because main utility lines for new high school come right through that area. If we can start line first part of June, will allow us to maintain schedule. It will not adversely impact instruction. Need to find an area for off-season weight training. Detailed plan on how to barricade those areas from the rest of the building.
- 5. Dr. Keenan: this is not a unique situation for buildings. We will take it seriously and communicate with our parents.

 Puffer: We will be doing tours for the 20/20 Vision Committee and Citizens for Westlake Schools, targeting Saturday, Nov. 17. By then the middle school will probably be under roof entirely. The high school is a little behind the middle school but on schedule.

#### TREASURER'S REPORT/RECOMMENDATIONS

- 1. Financial Presentation FY13 quarterly report and financial forecast.
  - a. HB386 requirement for schools and municipal entities will receive casino revenues. Initial estimates compared to most recent estimates show shortfalls. For Westlake we're expecting about \$19/student (@ \$77,000). Beginning next year they are projecting about \$50/student (@ \$200,000). Forecast hasn't changed much. On target with percentages we've set for budget for the first quarter. About 22% of budget expended at 25% into the year.
- 2. Approved student activity budgets and purpose statements for LBMS Drama Club and Builders Club
- 3. Approved Then and Now certificates for Mohican School in the Out-of-Doors, Sentry Fencing and Valley Forge Supply Inc.
- 4. Authorized a return of advance from Project Link to General Fund.

  - a. Tom Mays said he wished the schools would not have to pay for something the entire community enjoys out of school funds. A previous board entered into that agreement with the city.

- 7. Established appropriations for Ohio K-12 Network FY13.
- 8. Approved adjusting FY13 appropriations.
- 9. Authorized treasurer to secure all available tax advances from the State Auditor.
