F. Resolution Authorizing an Amendment to the Icon, LLC CMR Agreement for Site Work in Support of the New Elementary School in an Amount Not to Exceed \$5,273,295 and Authorizing the Administrative Team to Sign Change Orders Related to the Project in an Amount Not to Exceed \$500,000.00

WHEREAS, the District has been working with the Architect and ICON on the development of the plans and specification for the new school; and

WHEREAS, the Architect has developed the site drawings to the point that ICON can bid that portion of the project; and

WHEREAS, the early site work package consists of utility rough-ins, site grading, developing the building pad and contractor parking (including base layer of asphalt) and lay down areas; and

WHEREAS, beginning the early site work prior to the development of the final plans and specifications will allow work to begin this fall and reduce costs for the overall projects.

NOW, THEREFORE BE IT RESOLVED, by the Board of Education of the Westlake City School District, that

<u>Section 1</u>. This Board hereby authorizes the Treasurer to sign, on the District's behalf, a Guaranteed Maximum Price Amendment for the Early Site Work at the new Elementary School as described in the Architect's plans and specifications and in the GMP Amendment in an amount not to exceed \$5,273,295.00.

<u>Section 2</u>. In the event the District is signing a change order to document spending CMR Contingency funds or a Board approved allowances within the approved Guaranteed Maximum Price (GMP) Amendment(s) and the Architect consents, then the Treasurer may document that spending through a change order up to the amount of the CMR Contingency or previously approved allowances.

<u>Section 3</u>. In the event the District is adding to any GMP Amendment by adjusting the CMR's scope of work and the Architect is supportive of the Change Order, then: The Treasurer is authorized to sign change orders in an amount not to exceed \$25,000.

- The Treasurer and Business Manager may jointly sign change orders in an amount not to exceed \$50,000.
- The Treasurer, Business Manager, Superintendent of Schools, and a Board Member jointly are hereby authorized to sign change orders in an amount not to exceed \$100,000.
- All change orders over \$100,000 will be presented to the Board of Education for its consideration. All change orders are subject to certification of funds by the Treasurer and the total dollar amount that

the Administration may signed under this authority is capped at \$500,000 unless they seek additional approval from this Board.

<u>Section 4</u>. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this resolution were taken, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were held, in meetings open to the public, in compliance with the law.

<u>Section 5</u>. This resolution shall be in full force and effect from and immediately upon its adoption.
