Resolution 18-182

WHEREAS, Timothy R. Barrett notified the Westlake City School District Board of Education that he intended to retire as an Elementary Principal for the Westlake City School District ("the District") effective July 30, 2018, contingent upon being re-employed by the Board;

WHEREAS, Timothy R. Barrett provided the Board notice of his desire to be rehired for a duration of one (1) year in the same position as an Elementary Principal for the District, effective August 1, 2018, with such date of reemployment determined in compliance with the law;

WHEREAS, Ohio law allows a retired public school employee to be rehired;

WHEREAS, Timothy R. Barrett and the Board believe it to be mutually advantageous to rehire Timothy R. Barrett in the position of Elementary Principal for the District;

WHEREAS, the Board has given public notice at least 60 days before the reemployment of Timothy R. Barrett that Timothy R. Barrett will be retiring and will be seeking reemployment with the District. This public notice included the time, date and location of the public meeting regarding this issue of the Board reemploying Timothy R. Barrett;

WHEREAS, the Board's public meeting regarding the issue of Timothy R. Barrett being reemployed by the Board occurred between 15 and 30 days before the reemployment of Timothy R. Barrett; and

WHEREAS, the Board's Superintendent or designee negotiated a mutually favorable employment contract with Timothy R. Barrett.

NOW, THEREFORE, BE IT RESOLVED:

<u>Section 1.</u> In accordance with the law and the State of Ohio's retire/rehire program for public employees, contingent upon a mutually agreeable employment contract being executed and upon compliance with all required public notices and meetings, Timothy R. Barrett is hereby rehired as an Elementary Principal with the District for a duration of one (1) year, effective August 1, 2018, with such date of reemployment determined in compliance with the law.

<u>Section 2.</u> That the Board hereby adopts the employment contract with Timothy R. Barrett relating to the terms and conditions of his re-employment with the District, a copy of which contract is attached hereto as Attachment "A" and incorporated herein fully by reference.

<u>Section 3.</u> That this Board so charges the President of the Board, Superintendent, or Treasurer of the Board, or their designees, with carrying out any functions or steps necessary to effectuate this re-employment and employment contract with Timothy R. Barrett.

<u>Section 4</u>. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public or in executive session as permitted by Ohio law.

<u>Section 5.</u> This Resolution shall take effect and be in force from and after the earliest period allowed by law.
