D. Resolution Authorizing A Contract For Commissioning Services With The Brewer-Garrett Company In An Amount Not To Exceed \$137,360.00

WHEREAS, the District has been working with its architect their consultants on the plans and specifications for the new elementary school; and

WHEREAS, those plans and specifications include the design of mechanical systems; and

WHEREAS, school district's often engage in commissioning services to ensure quality design and construction of the mechanical systems and energy efficiency for school projects; and

WHEREAS, Lesko has recommended the use of a Commissioning consultant; and

WHEREAS, the District has engaged in a request for proposal process to retain a consultant to provide such commissioning services;

WHEREAS, Brewer-Garrett has performed those services for many school districts; and

WHEREAS, the proposal includes \$39,200 for commissioning, \$83,160 for testing and balancing of the HVAC system and \$15,000 for an Infrared Scan of the Building Envelope which may not be needed.

NOW, THEREFORE BE IT RESOLVED, by the Board of Education of the Westlake City School District, that:

E. Resolution Authorizing An Amendment to the ICON, LLC CMR Agreement For The New Elementary School In An Amount Not To Exceed \$32,181,646.89

WHEREAS, the District has been working with the Architect and ICON on the development of the plans and specification for the new school; and

WHEREAS, this Board has previously authorized an early site package, structural steel and concrete work; and

WHEREAS, ICON has bid all the work associated with the new elementary school other than technology equipment and loose fixtures furniture, equipment; and

WHEREAS, ICON and the Architect how best to provide for LED lighting and some insulation details.

NOW, THEREFORE BE IT RESOLVED, by the Board of Education of the Westlake City School District, that:

<u>Section 1</u>. This Board hereby authorizes the Treasurer to sign, on the District's behalf, a Guaranteed Maximum Price Amendment for the new Elementary School as described in the Architect's plans and specifications and in the GMP Amendment in an amount not to exceed \$32,181,646.89 in total.

<u>Section 2</u>. In the event the District is signing a change order to document spending CMR Contingency funds or a Board approved allowances within the approved Guaranteed Maximum Price (GMP) Amendment(s) and the Architect consents, then the Treasurer may document that spending through a change order up to the amount of the CMR Contingency or previously approved allowances.

<u>Section 3</u>. In the event the District is adding to any GMP Amendment by adjusting the CMR's scope of work and the Architect is supportive of the Change Order, then:

The Treasurer is authorized to sign change orders in an amount not to exceed \$25,000.

The Treasurer and Business Manager may jointly sign change orders in an amount not to exceed \$50,000.

The Treasurer, Business Manager and, Superintendent of Schools jointly are hereby authorized to sign change orders in an amount not to exceed \$100,000.

All change orders over \$100,000 will be presented to the Board of Education for its consideration. All change orders are subject to certification of funds by the Treasurer and the total dollar amount that the Administration may signed under this authority is capped at \$250,000 unless they seek additional approval from this Board.

<u>Section 4</u>. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this resolution were taken, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were held, in meetings open to the public, in compliance with the law.
