WHEREAS, the Employment Contract requires that no modification or amendment can be made except in writing and signed by the parties upon proper resolution of the Board;

WHEREAS, the Board and the Superintendent desire to continue the employment relationship beyond the current employment contract's expiration of July 31, 2020;

WHEREAS, Section 3319.01 of the Ohio Revised Code provides for the re-employment of school district superintendents for terms not longer than five (5) years beginning on the first day of August immediately following the expiration of the superintendent's current term of employment; and

WHEREAS, the Board and Superintendent have negotiated mutually agreeable provisions for a contract of employment as Superintendent for a term beginning on August 1, 2020 and ending on July 31, 2025 (the "Contract"), a copy of which is attached hereto and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED by the Board:

- <u>SECTION 1</u>. The Board hereby accepts the Contract of Employment, which is attached hereto as "<u>Exhibit A</u>" and incorporated herein fully by reference.
- <u>SECTION 2</u>. Be it further resolved that all other provisions of the Contract of Employment shall remain in full force and effect.
- <u>SECTION 3</u>. That the President of the Board and the Vice-President be, and they hereby are, authorized and directed to execute on its behalf the Contract of Employment with Scott Goggin.
- <u>SECTION 4</u>. The Board so charges the Treasurer with carrying out any other functions necessary to implement this Resolution.
- <u>SECTION 5</u>. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
