#### A. Discussion Items

1. 20/20 Committee Update

Superintendent Palmer discussed the February meeting of the 20/20 Committee and their input to date on Phase 2 of the District Master Facilities Plan. He also suggested obtaining a facilitator for the remainder of the 20/20 Phase II engagement process. He noted the next meeting is Thursday, March 12, at 6:30 at LBMS cafeteria.

# 2. Community Dialogue with Superintendent

Starting in April on each first Monday of the month at 10 am at Panera, the Superintendent will host an open 'coffee' dialogue session for any member of the community.

### 3. Senior Citizens Event

A Spring event to show appreciation to our senior citizens will take place on April 22<sup>nd</sup> at 5 pm. This will be a joint effort with the City of Westlake, Porter Library, Kiwanis Club and the school District.

#### 4. 2015-2016 School Calendar

Superintendent Palmer discussed the 2015-2016 school calendar options and noted one of the alternatives establishes an earlier start date to permit more instructional time prior to standardized testing. Mrs. Leszynski commented she can't support the current calendar the way it is because of the lack of instructional time prior to testing. She also asked why the other two options give two weeks at Christmas. She summarized the calendar option selected should be weighted in favor of the input of the teachers who have to administer the testing. Superintendent Palmer noted the Board will vote on the calendar will be at the April 13<sup>th</sup> meeting.

## 5. CIP Update

Superintendent Palmer noted the committee reconvened last Spring to make organizational shifts to accommodate the indicators. Recently, the administrative team has been fine tuning the process for review. The District will reconvene the various stakeholder groups next year to review and update the Plan.

#### \*Hearing of Public (15 Minutes)

Russ Ezolt stated he has never experienced a board or any group who is as arrogant as the Board. He noted the Board still did not have a podium for public comment. Ms. Winter indicated it was an oversight when setting up for the meeting. Mr. Ezolt then stated he had met with Dr. Keenan three times but hasn't met with Mr. Palmer because he's too busy.

Harry Applegate spoke about his participation on the 20/20 committee. He noted that based on the data, it was clear the District needed to build a new high school, a new middle school, and renovate the middle school, etc. He believes there is no need to use Burges & Burges to facilitate the process.

Russ Ezolt commented further about the Board and his views on Common Core.

Harry Applegate noted he attends the 20/20 committee meetings and asked a question about how students are taught with relation to the implementation of Common Core.

Russ Ezolt (Mr. Falcone reminded Mr. Ezolt there were two minutes left in the allotment for public comment) responded he would continue his comments at the next meeting and thanked the Board for letting the public speak their mind as well as noted the time he had to wait to speak after the meeting began. Mr. Falcone reminded Mr. Ezolt the meeting of the Board is to conduct business and is held in public and is not to be confused with a public meeting.

#### C. Board Comments

Mrs. Leszynski provided a legislative update on the financial waiver granted by the State Superintendent with respect to students who are opting out of testing. She noted concerns still remain regarding the ability to meet minimum required testing percentages and the potential loss of Federal funding. She also noted the Senate voted to pass HB7 which would prohibit using student scores on the PARCC assessments this year from being used for promotion and retention and granting course credit. This bill also prohibits the state from withholding the funding should a district have a large number of students opting out.

Harry Applegate – Asked the question, "As long as they take the tests, we get the funding?"

Ms. Winter noted the negative impact on the State report card rating if the students do not perform well.

Mr. Finucane asked if overall student testing has increased or have old tests replaced new tests.

Superintendent Palmer indicated students are taking more tests as the request for accountability has increased.

President Falcone discussed the upcoming public hearing to be held concerning the reemployment of Mr. Palmer. He noted the hearing is required by statute due to Mr. Palmer's retirement occurring on July 1, 2015. He was hired on an interim basis but will be officially retiring July 1, 2015
