Acknowledgment of Visitors – President LeChaix welcomed all visitors in attendance.

Hearing of Public (15 Minutes) Agenda Items – None.

A. Performing Arts Center Construction Update

Representatives present: Lou Trostle, on-site architect, Joel Shwartz, architect, Jay Waddell, Turner Construction, Karen Sweeney, Turner Construction.

Mr. Waddell provided an overview of the construction project to date:

- The foundation is 50-60% complete.
- The orchestra pit walls are being formed.
- The completion date has been moved to December 13, 2004. The arrival of steel on April 12, 2004 is critical to the project schedule.
- The project is still on budget.
- Orchestra pit drainage appears to be an error and omission. Discussion is underway with the architect on this issue.

D'Ettorre Wargo:

- Would like to know what the architect is willing to do as a result of the orchestra pit drainage situation.
- Would like an independent consultant to review the proposed TV studio equipment purchase.

O'Malley:

 Asked Turner Construction to briefly describe and clarify the construction contingency itemization.

Mrs. D'Ettorre Wargo exited the meeting at 7:44 a.m.

O'Malley:

- Asked Turner Construction to go through the change order process to date. Lou
 Trostle briefly spoke about the process. He indicated the architect first looks at the
 contractor comments and then prepares proposal requests to the prime contractors.
 Costs are then submitted to Turner to analyze, and then, change orders are prepared
 and submitted to the school district.
- Questions regarding minutes:
 - 1. What are coordination drawings? Trostle indicated these drawings are used by the various contractors to plan their work schedules, etc.
 - 2. What is the issue regarding fill? What is the potential exposure to the District? Waddell indicated the issue regarding fill rests with the general contractor and, in his opinion, does not affect the District.
 - 3. What is MEP underground? Waddell indicated this notation stood for Mechanical Electrical and Plumbing.
 - 4. Why did Mr. Waddell indicate items will need long lead times? (Miscellaneous items with project.) Waddell indicated he was referring to items that were not initially bid, such as the TV studio equipment, and wanted to bring this to management's attention.
