#### 1. Superintendent Transition

• Superintendent Keenan welcomed all visitors in attendance. He provided an overview of the superintendent transition to date. He indicated over the last several weeks he has reviewed a lot of district information, met with various community members, Board members, union leadership, central office staff and various City officials. He noted his involvement in the BASA superintendent mentoring program and stated he is looking forward to upcoming staff and site visitations.

#### 4. District Report Card

• The District received its ninth consecutive "Excellent" grade on the District Report Card scoring 29/30. It also achieved AYP (Adequate Yearly Progress) designation.

#### D. Board Items

<u>Mays</u>: He commended the girls' softball coach, Tom Shiban, for coordinating a practice for the middle school softball team.

Mays: He is still interested in pursuing the concept of advertising and naming rights as a way to raise additional revenue. He would like Superintendent Keenan to follow up with the Athletic Director on the survey of surrounding districts (how funds are raised), and would then like the Board to discuss formalizing a policy on this issue.

<u>Keenan</u>: He agreed to follow up on the survey with the Athletic Director. He indicated the district needs to exhaust all avenues to increase revenues. He suggested some community involvement/reaction to this issue would be warranted. In addition, he would also like to obtain feedback from potential user groups and the administration and report his findings to the Board.
